Subject: Coverage Extension and Reduction of covered units for the Special Service Campaign for the Fuel Pump Replacement on Multiple Toyota Models

Dear Atty. Porciuncula:

In line with the recent worldwide Special Service Campaign for the Fuel Pump Replacement on Multiple Toyota Models and our corporate commitment to product safety and quality, Toyota has extended the number of involved units related in our previous memorandum dated March 4, 2021 (CSO-TD21-LL-015).

The Special Service Campaign shall cover additional units of 32 Toyota 86 models.

Moreover, we would like to inform your good office that Toyota has reduced 806 units specifically for Toyota Avanza and Rush models as these were already previously repaired using the same improved countermeasure parts.

The Special Service Campaign updated coverage of units are from 47,505 to 46,731 Toyota vehicles officially sold in the Philippine market:
