Subject vehicles are equipped with front and rearview cameras which may experience camera case separation due to insufficient laser welding during production. This can lead to water leakage into the camera, causing short circuits and the failure to display images of the areas in front or behind the vehicle.

Involved customers will be notified by Toyota Motor Philippines through an Official Notification Letter and will be invited by Lexus Manila Inc. or any of our Lexus Accredited Dealers nationwide to conduct an inspection and/or replacement of the Camera. The remedy will be performed at **NO CHARGE** to vehicle owners.

Involved customers with vehicles included in the service campaign are highly encouraged to immediately set an appointment with an authorized Lexus Dealer to conduct the inspection and/or replacement of the Camera to prevent problems from occurring.
