#### Description

Invitation to Bid for Supply, Delivery, Installation, and Commissioning of Shared Service Facility for Embroidery of DTI Batangas Provincial Office (1 Lot)

1. The Department of Trade and Industry Region IV-A, through the General Appropriations Act FY 2022 intends to apply the sum of One Million Two Hundred Thousand Pesos (Php 1,200,000.00) being the ABC to payments under the contract for Supply, Delivery, Installation, and Commissioning of Shared Service Facility for Embroidery of DTI Batangas Provincial Office (1 Lot) (Bidding No.: 9203275). Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The Department of Trade and Industry Region IV-A now invites bids for the above Procurement Project. Delivery of the Goods is required to be completed within the indicated delivery schedule from receipt of Notice to Proceed and Purchase Order. Bidders should have completed, within three (3) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

3. Bidding will be conducted through open competitive bidding procedures using a non- discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

## TERMS OF REFERENCE

## Supply, Delivery, Installation, and Commissioning of Shared Service Facility for Embroidery of DTI Batangas Provincial Office (1 Lot)

#### I. Background

The Department of Trade and Industry- Shared Service Facility (SSF) project aims to increase MSMEs' productivity, enable them to tap a better and wider market share, and create more jobs, by providing machinery, equipment, tools, systems, accessories, and other auxiliary items, skills, and knowledge under a shared system.

Taal is known for its Burda; an art form of decorating fabrics and other materials. Though it may seem simple, it involves a long and painstaking process from the initial gathering and drying of raw materials like pineapple and abaca, to weaving these fibers using a loom, to finally decorating them with needle and thread. Despite the difficulties that come with it, through the centuries, the women of Taal have made Burdang Taal a viable cottage industry. Unfortunately, the younger generations of Burdaderos are losing their enthusiasm to continue their art, because of the speed and volume other competitors are able to achieve with their production due to having better technology. It is disappointing to discover that the embroidered products of Taal are not given as much value, making the industry gradually lose its spot in the market. The SSF for a Computerized Embroidery Machine aims to increase productivity which will allow Burdaderos to produce faster and more efficiently, without sacrificing quality. This, in turn, will hopefully enable the Burdaderos to tap a wider market share, rejuvenate their enthusiasm, and provide livelihood for Taaleneos.

# Glossary of Acronyms, Terms, and Abbreviations

ABC – Approved Budget for the Contract.

BAC – Bids and Awards Committee.

**Bid** – A signed offer or proposal to undertake a contract submitted by a bidder in response to and in consonance with the requirements of the bidding documents. Also referred to as *Proposal* and *Tender*. (2016 revised IRR, Section 5[c])

**Bidder** – Refers to a contractor, manufacturer, supplier, distributor and/or consultant who submits a bid in response to the requirements of the Bidding Documents. (2016 revised IRR, Section 5[d])

**Bidding Documents** – The documents issued by the Procuring Entity as the bases for bids, furnishing all information necessary for a prospective bidder to prepare a bid for the Goods, Infrastructure Projects, and/or Consulting Services required by the Procuring Entity. (2016 revised IRR, Section 5[e])

**BIR** – Bureau of Internal Revenue.

**BSP** – Bangko Sentral ng Pilipinas.

**Consulting Services** – Refer to services for Infrastructure Projects and other types of projects or activities of the GOP requiring adequate external technical and professional expertise that are beyond the capability and/or capacity of the GOP to undertake such as, but not limited to: (i) advisory and review services; (ii) pre-investment or feasibility studies; (iii) design; (iv) construction supervision; (v) management and related services; and (vi) other technical services or special studies. (2016 revised IRR, Section 5[i])

**CDA** - Cooperative Development Authority.

**Contract** – Refers to the agreement entered into between the Procuring Entity and the Supplier or Manufacturer or Distributor or Service Provider for procurement of Goods and Services; Contractor for Procurement of Infrastructure Projects; or Consultant or Consulting Firm for Procurement of Consulting Services; as the case may be, as recorded in the Contract Form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.

**CIF** – Cost Insurance and Freight.

## 1. Scope of Bid

## **3.** Bidding Requirements

Section IV. General Conditions of Contract

This is without prejudice to Sections 74.1 and 74.2 of the 2016 revised IRR of RA No. 9184 allowing the GPPB to amend the IRR, which shall be applied to all procurement activities, the advertisement, posting, or invitation of which were issued after the effectivity of the said amendment.

Additional requirements for the completion of this Contract shall be provided in the **Special Conditions of Contract (SCC).**

- 2.1. Advance payment of the contract amount is provided under Annex "D" of the revised 2016 IRR of RA No. 9184.
- 2.2. The Procuring Entity is allowed to determine the terms of payment on the partial or staggered delivery of the Goods procured, provided such partial payment shall correspond to the value of the goods delivered and accepted in accordance with prevailing accounting and auditing rules and regulations. ## **3.** Performance Security
