

SUPPLEMENTAL/BID BULLETIN NO. 2025-05

This Supplemental/Bid Bulletin No. 2025-05 is issued to *modify or amend portion* of the bidding documents relative to the conduct of public bidding for the invitation to Bid No. 2025-005 re: Provision of Various Food Processing Equipment for the Saint Joseph Parish Multi-Purpose Cooperative (SJMPC) – Belance in Dupax Del Norte, Nueva Vizcaya which was posted at the Philippine Government Electronic Procurement System (PhilGEPS), Procuring Entity's website and conspicuous places.
