



## INVITATION TO BID/ EXPRESSION OF INTEREST for the Philippine Participation in Expo 2020 Dubai for the Hiring of a Transportation Services Company

- 6. Bidding is open to all interested bidders registered in Dubai UAE subject to the conditions for eligibility as contained in the attached Terms of Reference.
- 7. The contract duration will be for a period of forty-two (42) days from **21 July 2021 to 31 August 2021.**

The *Department of Trade and Industry (DTI)*, reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
