# 2025 Presidential Recognition for Outstanding Development Partners

An initiative to recognize development partners and cite programs and services that best serve the MSME sector.

#### **RECOGNITION CATEGORIES**

Outstanding development partners implementing programs under the following categories shall be recognized:

- Strengthening MSME Ecosystem This category refers to development partners that create a conducive business environment for MSMEs through policies, regulatory reforms, incentives, and ease of doing business initiatives.
- Increasing Financing Prospects This category refers to development partners that improve MSME access
  to funding, credit, or investment opportunities.
- Upscaling Knowledge and Skills This category refers to development partners that provide training, mentorship, or education for MSME capacity building.
- Accelerating Technology and Innovation This category refers to development partners that promote and facilitate MSME adoption of new technologies and innovative solutions.
- Optimizing Domestic Markets This category refers to development partners that help MSMEs expand within local markets and strengthen market linkages.
- Penetrating Global Markets This category refers to development partners that support MSMEs in entering and competing in international markets.

## **ELIGIBILITY/QUALIFYING CRITERIA**

- The Nominee must be a government agency, including local government units (LGUs), government instrumentalities, and government-owned and controlled corporations (GOCCs), non-government organizations, academic institutions, civil society organizations, and private sector with excellent programs and services that must have a national scope— except for Local Government Units (LGUs), which may be nominated regardless of their coverage. (Note: For context, 'national scope' refers to having a presence in at least one region per island group.
- Development partners that have previously received any Presidential Awards/ Recognition (at the time of nomination), regardless of the awards category, may no longer be nominated.
- The development partner's program/ project must fall under any of the enumerated categories above. The nominee shall be evaluated solely on the strategic area/ category for which they are nominated. Each nomination must specify one (1) category, and no nominee shall be considered for multiple areas.
- The development partner must be registered with or accredited by the appropriate government agency based on its nature (except for government agencies).
- The program must have been recently implemented and in operation for at least three (3) years.
- The program must have verifiable and significant results.

## **NOMINATIONS**

# Who may nominate:

- Government agencies, including local government units (LGUs), government instrumentalities, and government-owned and controlled corporations (GOCCs), private organizations (e.g. industry associations, chambers of commerce and industry, business organizations like cooperatives), academic institutions, civil society organizations, and non-government organizations. Such entities may nominate their partner agencies involved in implementing programs and services for MSME development.
- MSMEs may nominate government agencies, private institutions, civil society organizations, academic institutions, and/or non-government organizations for programs they have significantly benefited from.
- Self-nomination may be accepted.

#### Where to submit nominations:

Cover letter, Nomination Forms, and supporting documents must be submitted by the Nominating Entity or the development partner (if self-nominated) on or before 16 May 2025 to the following:
