The duration of the contracts shall be three (3) years commencing on 1 May 2026 or on a date the Government of the Hong Kong Special Administrative Region shall specify by notice. The notice of tender invitation is published in the Government Gazette, the Transport Department's Homepage and two (2) local newspapers, namely The Standard and Ming Pao, today. A copy of the Transport Department Notice containing details of the tender invitation is attached for your easy reference.

Interested parties may obtain the tender documents during office hours from 10 October 2025 (Friday) by producing a company letter indicating their interest to bid for the contracts from the Business Management Section of Transport Department on 14/F, South Tower, West Kowloon Government Offices, 11 Hoi Ting Road, Yau Ma Tei, Kowloon.

To facilitate tenderers in accessing tender information, downloading tender documents and submitting tenders electronically, the Government has developed and launched an electronic tendering system, namely e-Tendering System ("e-TS"). 

It is hereby notified that sealed tenders are invited for the following contracts:

- (i) Contract for management, operation and maintenance of Government Carparks (Contract A) (Tender Reference: TD(T) 13/2024); and
- (ii) Contract for management, operation and maintenance of Government Carparks (Contract B) (Tender Reference: TD(T) 14/2024).

Interested parties may submit tender(s) for (i) and/or (ii) of the above-mentioned contracts. The duration of the contracts shall be three (3) years commencing on 1 May 2026 or on a date as the Government of the Hong Kong Special Administrative Region shall specify by notice.

For paper-based tendering, tenders must be clearly marked with the tender reference and the subject of the tender on the outside of a sealed envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Central Tender Board, and placed in the Government Secretariat Tender Box situated at the Lobby of the Public Entrance on the Ground Floor of East Wing of Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong **before 12:00 noon on Friday, 5 December 2025** (Hong Kong time). Tenders must be deposited in the tender box as specified in this tender notice (“Specified Tender Box”) before the tender closing time. For electronic tendering, transmission of a tender through the e-TS shall be successfully completed in accordance with the requirement of the e-TS before the tender closing time. Late tenders or tenders not deposited in the Specified Tender Box will not be accepted.

If tropical cyclone signal No. 8 or above is hoisted, or a black rainstorm warning signal or “extreme conditions” announced by the Government is/are in force at any time between 9:00 a.m. and 12:00 noon on 5 December 2025 (Friday) (Hong Kong time), the tender closing time will be postponed to 12:00 noon (Hong Kong time) on the first working day after the tropical cyclone signal No. 8 is lowered, or the black rainstorm warning signal or the “extreme conditions” announced by the Government has/have ceased to be in force.

In case of blockage of the public access to the location of the Specified Tender Box at any time between 9:00 a.m. and 12:00 noon on 5 December 2025 (Friday) (Hong Kong time), the Government will

announce the extension of the tender closing time until further notice. Following the removal of the blockage, the Government will announce the extended tender closing time as soon as practicable. The above announcements will be made via press releases on the website of the Information Services Department (<http://www.info.gov.hk/gia/general/today.htm>).

To facilitate the preparation of tenders, a tender briefing session will be arranged on 24 October 2025 (Friday) for prospective tenderers. For tenderers who are interested in participating in the tender briefing session, please contact Business Management Section of the Transport Department (Tel: 3842 5871; Fax: 2877 5768) on or before 21 October 2025 (Tuesday).

Open tendering is adopted. All interested contractors are invited to tender.

The Government of the Hong Kong Special Administrative Region does not bind itself to accept the tender with the highest overall score or any tender, and reserves the right to negotiate with any tenderer about the terms of the offer.
