The cover of the tender submission should be clearly marked with the tender reference and the subject of the tender (but should not bear any indication which may relate the tender to the tenderer). Following the removal of the blockage, the Government will announce the extended tender closing time as soon as practicable. The above announcements will be made via press releases on the website of the Information Services Department (<http://www.info.gov.hk/gia/general/today.htm>). Late tenders will not be accepted.
