It is hereby notified that sealed tenders in quadruplicate are invited for Contract No. EP/SP/186/21—West New Territories Landfill Extension (Public Works Programme Item No. 5192DR). The scope of the contract comprises the design and construction of the works for the West New Territories Landfill Extension (including site formation, installation of liner system, and provision of leachate treatment and landfill gas management system), environmental monitoring, landfill operation, restoration and aftercare of the landfill at Nim Wan, Tuen Mun, New Territories, Hong Kong. The contract is scheduled to commence in June 2023.
