Closing Date/Time:

In case of blockage of the public access to the location of the specified tender box at any time between 9:00 a.m. and 12:00 noon on the tender closing date, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce extended tender closing time as soon as practicable. The above announcements will be made via press releases on the website of Information Services Department (https://www.info.gov.hk/gia/general/today.htm).

All time references are Hong Kong time.

Submission of Tenders

Tenders in three (3) sets of hard copies and two (2) sets of soft copies must be sealed and clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Central Tender Board, and placed in the Government Secretariat Tender Box situated at the Lobby of the Public Entrance on the Ground Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong before the tender closing date/time. Late tenders or tenders not deposited in the specified tender box will not be accepted.

a. Open tendering is adopted. All interested contractors/suppliers/service providers are invited to tender.
