- in paper form enclosed in a sealed plain envelope, marked "*Tender for the Provision of the branding campaign to the Primary Healthcare Commission of Health Bureau (Tender Ref.: HHB/PHCC/24/5)*" (without bearing any distinguishing matter, mark or advertisement to indicate the identity of tenderer), addressed to the Chairman, Tender Opening Committee, Government Logistics Department, and deposited in the Government Logistics Department Tender Box ("Specified Tender Box") situated at Ground Floor, North Point Government Offices, 333 Java Road, North Point, Hong Kong.

Late tenders or tenders not deposited in the Specified Tender Box will not be considered.
