### NOTICE OF TENDER INVITATION

#### TENDER FOR AGREEMENT FOR MANAGEMENT, OPERATION AND MAINTENANCE OF CROSS-HARBOUR TUNNEL

It is hereby notified that sealed tenders are invited for the agreement for management, operation and maintenance of Cross-Harbour Tunnel for the Transport Department (Tender Reference: TD (T) 4/2021). The duration of the agreement shall be six (6) years commencing on 1 November 2022 or on a date the Government of the Hong Kong Special Administrative Region shall specify by notice.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Central Tender Board, and placed in the Government Secretariat Tender Box situated at the Lobby of the Public Entrance on the Ground Floor of East Wing of Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong **before 12:00 noon on Friday, 24 June 2022** (Hong Kong time). Tenders must be deposited in the tender box as specified in this tender notice ("Specified Tender Box") before the tender closing time. Late tenders or tenders not deposited in the Specified Tender Box will not be accepted. If tropical cyclone signal No. 8 or above is hoisted, or a black rainstorm warning signal or "extreme conditions after super typhoons" announced by the Government is/are in force at any time between 9:00 a.m. and 12:00 noon on 24 June 2022 (Friday), the tender closing time will be postponed to 12:00 noon (Hong Kong time) on the first (1<sup>st</sup>) working day after the tropical cyclone signal No. 8 is lowered, or the black rainstorm warning signal or the "extreme conditions after super typhoons" announced by the Government has/have ceased to be in force. In case of blockage of the public access to the location of the Specified Tender Box at any time between 9:00 a.m. and 12:00 noon (Hong Kong time) on 24 June 2022 (Friday), the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable. The above announcements will be made via press releases on the website of Information Services Department (<http://www.info.gov.hk/gia/general/today.htm>).

Open tendering is adopted. All interested contractors are invited to tender.
