

DEPARTMENT OF TRADE AND INDUSTRY FREEDOM OF INFORMATION (FOI) PEOPLE'S MANUAL

Section 1. Overview

- **1.1. Purpose.** The purpose of this FOI Manual is to guide the public in requesting for information from the Department of Trade and Industry (DTI) as prescribed under Executive Order (EO) No. 2 (s. 2016).
- 1.2. Policy Statement. In line with the constitutional mandate upholding the right to freedom of information and implementation of full public disclosure of all its transactions involving public interest, the DTI is committed to release information to the public involving public interest, subject to limitations as provided by the Constitution, applicable laws, rules, regulations and procedures, such as Republic Act (RA) No. 10173, otherwise known as the "Data Privacy Act," and the List of Exceptions approved by the Office of the President, among others.

Section 2. Scope

This Manual includes the following information:

Section 3. Coverage

This Manual covers all requests for information directed to the DTI Central Office, including the Regional and Provincial Offices. These Offices are provided in the attached Annex D.

Section 4. DTI Attached agencies and corporations

The following attached agencies and corporations of DTI shall have their respective FOI Manual and published on their website for information of the public:

Section 5. Duties and Responsibilities

The DTI Central Office and Regional Offices shall designate their respective FOI Receiving Officers (FROs) and FOI Decision Makers (FDMs).

- **5.1. FOI Receiving Officer (FRO).** The FRO shall, among others, perform to:
 - Receive on behalf of DTI all requests for information and facilitate such requests;
 - Ensure that the FOI request form is completely accomplished;
 - Provide assistance and support with regard to FOI;
 - Process all requests and forward to the concerned office (within and outside DTI) as may be appropriate; and
 - Provide assistance in ensuring all requests are responded to within the prescribed time.
 - **5.1.1. FOI Receiving Officer (FRO) for Central Office.** The designated FOI Receiving Officer (FRO) at the Central Office is the Public Assistance Desk (PAD) Officer of the Day, with the following address:

5.1.2. FRO for the Regions. The designated FRO for the regional and provincial offices are provided in Annex E.

Section 6. Guidelines on the Request for Information

All requests for information must be guided as follows:

- **6.1** Requests must be in writing and filled up using the prescribed FOI Request Form (Annex B).
- Requests may also be coursed through email. A copy of the FOI Request Form can be downloaded from the DTI website at www.dti.gov.ph/foi. The completely filled up form should be sent to foi@dti.gov.ph.
- 6.3 Requests whether in writing or email must contain the name and contact information of the requesting party and be submitted with an acceptable proof of identification (i.e. government ID with photo).
- 6.4 In case the requesting party is unable to make a written request because of illiteracy or due to being a person with disability, he or she may make an oral request to the concerned FRO, which the FRO shall put in writing using the prescribed form, to be signed by the requesting party.

Section 7. Standard Procedure

7.1. Receipt of Request for Information

- a. The requesting party shall fill up and submit the FOI Request Form (Annex B) to the nearest DTI office.
- b. The request shall be stamped received by DTI, indicating the date and time of the receipt of the written request.
- c. The requesting party must expect a response from DTI within fifteen (15) working days following the date of receipt of the request. A working day is any day other than a Saturday, Sunday or a day which is declared a national public holiday in the Philippines.
- d. Should the requested information need further details to identify or locate, the fifteen (15) working days will commence the day after it receives the required clarification from the requesting party. In such cases, the requesting party shall be informed by DTI.
- **7.2.** Request for an Extension of Time. If the information requested requires extensive search of the government's office records facilities, examination of voluminous records, the occurrence of fortuitous events or other analogous cases, the requesting party shall be informed by the DTI.

The requesting party shall be informed of the extension, setting forth the reasons for such extension. In no case shall the extension exceed twenty (20) working days on top of the mandated fifteen (15) working days to act on the request, unless exceptional circumstances warrant a longer period.

- **7.3.** Notifying the Requesting Party of the Approval/Denial of the Request. Once the DTI approves or denies the request, the requesting party shall be notified by DTI either in writing or by email.
- **7.4. Approval of Request.** In case of approval, the DTI shall ensure that all records that have been retrieved and considered be checked for possible exemptions, prior to actual release. The DTI shall prepare the letter or email informing the requesting party within the prescribed period that the request was granted.
- **7.5. Denial of Request.** In case of denial of the request wholly or partially, the requesting party shall be notified by the DTI, within the prescribed period, of the denial in writing. The notice shall clearly set forth the ground or grounds for denial and the circumstances on which the denial is based.

Section 8. Remedies in case of Denial

- **8.1.** A person whose request for access to information has been denied may avail himself of the remedy set forth below.
 - a. For the Central Office, a written appeal must be filed by the requestor within fifteen (15) days from receipt of the notice of denial
 - b. The request for appeal must be addressed to and contain the subject FOI:

- c. For requests denied at the Regional Office, the appeal must be submitted by the requestor to the concerned Regional Director.
- **8.2.** The appeal shall be decided within thirty (30) working days from the filing of said written appeal.
- **8.3.** The decision of the appeals authority shall be final.

8.4. The requesting party may file a case in the proper courts upon exhaustion of administrative remedies.

Section 9. Fees

The requesting party shall not be charged with any fee for submitting requests for access to information.

Section 10. No Wrong Door Policy

In compliance with FOI-MC No. 21-05 or the Guidelines on the Referral of Requested Information, Official Record/s and Public Record/s to the Appropriate Government Agency, otherwise known as the "No Wrong Door Policy for FOI," the DTI will not deny FOI requests for information and/or records not under its possession but instead refer the request to the appropriate government agency which is the proper repository or custodian of the requested information or records, or have control over the said information or records (See Annex C).

Section 11. Administrative Liability

DTI's failure to comply with the provisions of this Manual shall be deemed a violation of reasonable office rules and regulations.


The Revised Rules on Administrative Cases in the Civil Service shall be applicable in this case.


Annex A-1

FOI Appeal Flow





Exceptions to Right of Access to Information

For the guidance of all government offices and instrumentalities covered by EO No. 2 (s. 2016) and the general public, the following are the exceptions to the right of access to information, as recognized by the Constitution, existing laws, or jurisprudence:

- 1. Information covered by executive privilege;
- 2. Privileged information relating to national security, defense, or international relations;
- 3. Information concerning law enforcement and protection of public and personal safety;
- 4. Information deemed confidential for the protection of the privacy of persons and certain individuals such as minors, victims or crimes, or the accused;
- 5. Information, documents or records known by reason of official capacity and are deemed as confidential, including those submitted or disclosed by entities to government agencies, tribunals, boards or officers, in relation to the performance of their functions, or to inquiries or investigation conducted by them in the exercise of their administrative, regulatory, or quasi-judicial powers;
- 6. Prejudicial premature disclosure;
- 7. Records of proceedings or information from proceedings which, pursuant to law or relevant rules and regulations, are treated as confidential or privileged;
- 8. Matters considered confidential under banking and finance laws, and their amendatory laws; and
- 9. Other exceptions to the right to information under laws, jurisprudence, rules, and regulations.
