**A RESOLUTION RECOMMENDING AWARD TO TOYOTA PASONG TAMO, INC. FOR THE SUPPLY AND DELIVERY OF VARIOUS MOTOR VEHICLES FOR THE DEPARTMENT OF TRADE AND INDUSTRY (DTI) (BIDDING NO. 23-043)**

**WHEREAS**, the Department of Trade and Industry – Bids and Awards Committee (DTI-BAC) conducted an early procurement for the **Supply and Delivery of various Motor Vehicles for the Department of Trade and Industry (DTI)**, pursuant to the Implementing Rules and Regulations (IRR) of Republic Act No. 9184 (Government Procurement Reform Act), with the following Approved Budget for the Contract:

**WHEREAS**, the DTI-BAC conducted the Pre-Bidding Conference on 04 December 2023, using the Zoom video conferencing platform, in accordance with GPPB Resolution No. 09-2020, attended by the following bidders:

1. **Toyota Pasong Tamo, Inc.;**
2. **Alpine Motors Inc.;**
3. **MCX International Inc.;** and
4. **Zoomhub Inc.;**

A copy of the minutes of the meeting is hereto attached, marked as Annex “B”, and made an integral part hereof;

**WHEREAS**, one (1) bid was received for each lot before the deadline on 18 December 2023 from **Toyota Pasong Tamo, Inc.;**

**WHEREAS**, the DTI-BAC opened the bids on 18 December 2023, using the mandatory principle of “pass/fail” or the presence/absence of eligibility and technical

documents, the DTI-BAC provisionally declared **Toyota Pasong Tamo, Inc.** as eligible for having submitted the complete documents;

**WHEREAS**, upon preliminary evaluation of the technical and financial proposals submitted by the bidder, the same were found to be compliant, to wit:

**WHEREAS**, pursuant to Sec. 34.1 of the Revised Implementing Rules and Regulations of RA 9184, and in order to conduct the Post Qualification, "Notice of Single Calculated Bid" was sent on 22 December 2023, and received by **Toyota Pasong Tamo, Inc.** on 27 December 2023. The copy of the Notice is hereto attached, marked as Annex "E", and made an integral part hereof;

**WHEREAS**, the post-qualification was conducted on 29 December 2023. A copy of the post-qualification report is hereto attached, marked as Annex "F" and made an integral part hereof;


**WHEREAS**, upon careful examination, validation and verification of the following: (1) eligibility documents, (2) technical and financial proposals, (3) evaluation of the end-user, and (4) evaluation of the company site, the bid submitted by **Toyota Pasong Tamo, Inc.**, was found to be responsive and compliant.

**NOW, THEREFORE**, we the Members of the Bids and Awards Committee resolve as it is hereby resolved:

1. To declare **Toyota Pasong Tamo, Inc.** as the bidder with the **Single Calculated and Responsive Bid** for the **Supply and Delivery of various Motor Vehicles for the Department of Trade and Industry (DTI) for Lot Nos. 1 and 2;**
2. To recommend to the Head of Procuring Entity (HOPE) to award the said project to **Toyota Pasong Tamo, Inc.** at a contract price of **Fifteen Million Nine Hundred Forty-Seven Thousand Six Hundred Ninety Pesos (PhP15,947,690.00) for Lot No. 1;**

3. To recommend to the Head of Procuring Entity (HOPE) to award the said project to **Toyota Pasong Tamo, Inc.** at a contract price of **Three Million Five Hundred Fifty-Five Thousand Four Hundred Pesos (PhP3,555,400.00)** for Lot No. 2.
