**WHEREAS**, the DTI-BAC issued Bid Bulletin No. 1 to announce amendment in the bidding documents prior to the opening of bids;

**WHEREAS**, no bid was received for Lot Nos. 1 and 2 before the deadline on 08 July 2024;

**WHEREAS**, one (1) bid was received for Lot No. 3 before the deadline on 08 July 2024 from **Joneco Tech Marketing Corp.**;

**WHEREAS**, the DTI-BAC opened the bids on 08 July 2024, using the mandatory principle of "pass/fail" or the presence/absence of eligibility and technical documents, the DTI-BAC provisionally declared **Joneco Tech Marketing Corp.** as eligible for having submitted the complete documents;

**WHEREAS**, upon preliminary evaluation of the technical and financial proposals submitted by the bidder, the same were found to be compliant, to wit:
