#### **A RESOLUTION RECOMMENDING AWARD TO ADVANCE MICROSYSTEMS CORPORATION FOR THE NEGOTIATED PROCUREMENT OF VARIOUS ICT EQUIPMENT AND PERIPHERALS FOR THE DEPARTMENT OF TRADE AND INDUSTRY LOT NO. 1 (BIDDING NO. 23-030)**

**WHEREAS**, the Department of Trade and Industry – Bids and Awards Committee (DTI-BAC) conducted the Negotiated Procurement (Two-Failed Bidding) for the **Procurement of Various ICT Equipment and Peripherals for the Department of Trade and Industry**, pursuant to the Implementing Rules and Regulations (IRR) of Republic Act No. 9184 (Government Procurement Reform Act), with an Approved Budget for the Contract amounting to **Five Million Seven Hundred Seventy-Nine Thousand Nine Hundred Eighty Pesos (PhP5,779,980.00)** with Purchase Request No. 75521;

WHEREAS, the DTI-BAC declared a second failure of bidding pursuant to BAC Resolution No. 162, s. 2024;

**WHEREAS**, the DTI-BAC caused the mandatory publication/posting of the invitation to bid for the said project on the following channels as prescribed by the IRR of RA 9184: PhilGEPS website, DTI website, as well as in conspicuous places within and outside DTI premises;

**WHEREAS**, the DTI-BAC conducted the Negotiated Conference on 19 August 2024, using the Zoom video conferencing platform, in accordance with GPPB Resolution No. 09-2020 attended by the following bidders:

- 1. Joneco Tech Marketing Corp.; and**
- 2. Accent Micro Technologies Inc.;**

**WHEREAS**, the DTI-BAC issued Bid Bulletin Nos. 1, 2, and 3, to announce amendment in the bidding documents prior to the opening of bids;

**WHEREAS**, two (2) bids were received before the deadline on 16 September 2024 from the following bidders:

1. **Sonkkens Office Equipment Trading;** and
2. **Advance Microsystems Corporation;**

**WHEREAS**, the DTI-BAC opened the bids on 16 September 2024, using the mandatory principle of “pass/fail” or the presence/absence of eligibility and technical documents, the DTI-BAC provisionally declared **all bidders** as eligible for having submitted the complete documents;

**WHEREAS**, upon preliminary evaluation of the technical and financial proposals submitted by the bidder, the same were found to be compliant, to wit:

**WHEREAS**, the post-qualification was conducted to **Sonkkens Office Equipment Trading** on 26 September 2024;

**WHEREAS**, the end-user submitted the evaluation for the offered units of Sonkkens Office Equipment Trading on 27 September 2024 with few clarifications, hence, the BAC Secretariat coordinated on 01 October 2024 with the latter for the said concerns which was then confirmed by Sonkkens Office Equipment Trading;

**WHEREAS**, the end-user evaluated the latest technical specifications of the units confirmed by Sonkkens Office Equipment Trading, and provided a result that the latter

did not meet the minimum requirements, hence, the end-user proceed in evaluating the second lowest bidder, Advance Microsystems Corporation;

**WHEREAS**, pursuant to Sec. 34.1 of the Revised Implementing Rules and Regulations of RA 9184, and in order to conduct the Post Qualification, “Notice of Second Lowest Calculated Bid” was sent to and received by and received by **Advance Microsystems Corporation** on 07 November 2024;

A copy of the Notice is hereto attached, marked as Annex “L”, and made an integral part hereof;

**WHEREAS**, an on-site post-qualification was conducted to **Advance Microsystems Corporation** at their company office in Pasig City on 08 November 2024;


A copy of the post-qualification report is hereto attached, marked as Annex “M”, and made an integral part hereof;


**WHEREAS**, upon careful examination, validation and verification of the following: (1) eligibility documents, (2) technical and financial proposals, (3) evaluation of the end-user, and (4) evaluation of the company site, the bid submitted by **Advance Microsystems Corporation**, was found to be responsive and compliant.


**NOW, THEREFORE**, we the Members of the Bids and Awards Committee resolve as it is hereby resolved:


1. To declare **Advance Microsystems Corporation** as the bidder with the **Lowest Calculated and Responsive Bid** for the **Procurement of Various ICT Equipment and Peripherals for the Department of Trade and Industry**; and
2. To recommend to the Head of Procuring Entity (HOPE) to award the said project to **Advance Microsystems Corporation** at a contract price of **Five Million Six Hundred Thirty-Four Thousand Pesos (PhP5,634,000.00)**.


