WHEREAS, the Department of Trade and Industry – Bids and Awards Committee (DTI-BAC) conducted an Early Procurement for the **Procurement of Digital Gift Checks/Certificates for Judges of the Young Creatives (YC2) Season 2**, pursuant to the Implementing Rules and Regulations (IRR) of Republic Act No. 9184 (Government Procurement Reform Act), with an Approved Budget for the Contract of **Two Million Five Hundred Thousand Pesos (PhP2,500,000.00)** with Purchase Request No. 80525;

WHEREAS, the DTI-BAC conducted the Pre-Bidding Conference on 25 November 2024, using the Zoom video conferencing platform, in accordance with GPPB Resolution No. 09-2020, attended by **Pluxee Philippines Incorporated**;

A copy of the minutes of the meeting is hereto attached, marked as Annex “B”, and made an integral part hereof;

WHEREAS, one (1) bid was received before the deadline on 09 December 2024 from **Pluxee Philippines Incorporated**;

WHEREAS, the DTI-BAC opened the bids on 09 December 2024, using the mandatory principle of “pass/fail” or the presence/absence of eligibility and technical documents, the DTI-BAC provisionally declared **Pluxee Philippines Incorporated** as **eligible** for having submitted the complete documents;

WHEREAS, upon preliminary evaluation of the technical and financial proposals submitted by the bidder, the same were found to be compliant, to wit:

WHEREAS, the post-qualification was conducted to **Pluxee Philippines Incorporated** on 26 December 2024;


A copy of the post-qualification report is hereto attached, marked as Annex "F", and made an integral part hereof;
