#### **A RESOLUTION RECOMMENDING AWARD TO MASANGKAY COMPUTER CENTER FOR THE SUPPLY AND DELIVERY OF LAPTOP COMPUTERS (BIDDING NO. 24-055)**

**WHEREAS**, the Department of Trade and Industry – Bids and Awards Committee (DTI-BAC) conducted an Early Procurement for the **Supply and Delivery of Laptop Computers**, pursuant to the Implementing Rules and Regulations (IRR) of Republic Act No. 9184 (Government Procurement Reform Act), with an Approved Budget for the Contract of **Five Million Twenty-Two Thousand Five Hundred Fifty-Five Pesos (PhP5,022,555.00)** with Purchase Request No. 82088;

**WHEREAS**, the DTI-BAC caused the mandatory publication/posting of the invitation to bid for the said project on the following channels as prescribed by the IRR of RA 9184: PhilGEPS website, DTI website as well as in conspicuous places within and outside DTI premises;

**WHEREAS**, upon careful examination, validation and verification of the following: (1) eligibility documents, (2) technical and financial proposals, (3) evaluation of the end-user, and (4) evaluation of the company site, the bid submitted **Masangkay Computer Center**, was found to be responsive and compliant.

**NOW, THEREFORE**, we the Members of the Bids and Awards Committee resolve as it is hereby resolved:

1. To declare **Masangkay Computer Center** as the bidder with the **Lowest Calculated and Responsive Bid** for the **Supply and Delivery of Laptop Computers**; and
2. To recommend to the Head of Procuring Entity (HOPE) to award the said project to **Masangkay Computer Center** at a contract price of **Four Million Eighty Hundred Ninety-Nine Thousand Four Hundred Ninety-Two Pesos (PhP4,899,492.00)**; and
3. This is an early procurement subject to approval and release of the approved FY 2025 GAA.
