A RESOLUTION RECOMMENDING AWARD TO CERTEGY EVENT SOLUTION FOR THE PROVISION OF SERVICE FOR THE CONDUCT OF OTOP FOOD AND BEAUTY FAIR (BIDDING NO. 24-009)

WHEREAS, the Department of Trade and Industry – Bids and Awards Committee (DTI-BAC) conducted a Public Bidding for the **Provision of Service for the Conduct of OTOP Food and Beauty Fair**, pursuant to the Implementing Rules and Regulations (IRR) of Republic Act No. 9184 (Government Procurement Reform Act), with an Approved Budget for the Contract of **Seventeen Million Five Hundred Thousand Pesos (Php17,500,000.00)** with Purchase no. 72968;

WHEREAS, the DTI-BAC caused the mandatory publication/posting of the invitation to bid, for the second time, for the said project on the following channels as prescribed by the IRR of RA 9184: PhilGEPS website, DTI website, as well as in conspicuous places within and outside DTI premises;

WHEREAS, the DTI-BAC conducted the Pre-Bidding Conference on 13 May 2024, using the Zoom video conferencing platform, in accordance with GPPB Resolution No. 09-2020, attended by the following bidders:

- 1. Certegy Event Solution;**
- 2. Tradepeak Corp;**
- 3. Browne Communications; and**
- 4. ProEvent;**

A copy of the minutes of the meeting is hereto attached, marked as Annex “B”, and made an integral part hereof;

WHEREAS, the DTI-BAC issued Bid Bulletin No. 1 to announce amendment in the bidding documents prior to the opening of bids;

A copy of Bid Bulletin No. 1 is hereto attached, marked as Annex “C”, and made an integral part hereof;

WHEREAS, one (1) bid was received before the deadline on 27 May 2024 from **Certegy Event Solution;**

WHEREAS, the DTI-BAC opened the bids on 27 May 2024, using the mandatory principle of “pass/fail” or the presence/absence of eligibility and technical documents, the DTI-BAC provisionally declared **Certegy Event Solution** as eligible for having submitted the complete documents;

WHEREAS, upon preliminary evaluation of the technical and financial proposals submitted by the bidder, the same were found to be compliant, to wit:

WHEREAS, pursuant to Sec. 34.1 of the Revised Implementing Rules and Regulations of RA 9184, and in order to conduct the Post Qualification, "Notice of Single Calculated Bid" was sent to and received by **Certegy Event Solution** on 29 May 2024. The copy of the Notice is hereto attached, marked as Annex "F", and made an integral part hereof;

WHEREAS, an on-site post-qualification was conducted to **Certegy Event Solution** at their company office in Antipolo City, Rizal, on 30 May 2024, and their warehouses in Parañaque and Caloocan City on 07 June 2024. A copy of the post-qualification report is hereto attached, marked as Annex "G", and made an integral part hereof;

WHEREAS, upon careful examination, validation and verification of the following: (1) eligibility documents, (2) technical and financial proposals, (3) evaluation of the end-user, and (4) evaluation of the company site, the bid submitted by **Certegy Event Solution**, was found to be responsive and compliant.

NOW, THEREFORE, we the Members of the Bids and Awards Committee resolve as it is hereby resolved:

1. To declare **Certegy Event Solution** as the bidder with the **Single Calculated and Responsive Bid** for the **Provision of Service for the Conduct of OTOP Food and Beauty Fair**; and
2. To recommend to the Head of Procuring Entity (HOPE) to award the said project to **Certegy Event Solution** at a contract price of **Seventeen Million Four Hundred Ninety-Four Thousand Three Hundred Fifteen Pesos (PhP17,494,315.00)**.




