## 2. Terms of Reference

## A. SCOPE OF WORK AND DELIVERABLES

- Provision of technical support for system maintenance which includes optimization, error correction, enhancement of existing features, software updates and full remote back up of the system application and its database.
- Provision of ICT infrastructure to support system application and backup requirements.

- Conduct of meetings, consultations, presentations, pilot testing, and training of the
  officers in the Bureau and its stakeholders for the mapping of work process and
  data gathering, which will be done either face to face or through virtual/online
  platforms depending on the situation.
- Recommendation on software licenses, hardware requirements and O/S platform on which the application shall run on. The proposed solution should cover recommendation on any and all software products and hardware platforms and peripherals required to meet the specifications of this TOR, including system integration services and tools used in its enhancement, development and customization. These applications shall be compatible with the existing systems being used by the DTI.

## **B. DELIVERABLES**

• The system shall be compatible to be linked with other systems; such as: Standard and Conformance Portal, DTI Pay, TradeNet, and ICC Verification App.

**Standard and Conformance Portal** is a website or online facility that offers an easy access to a wide range of information on standards, regulations and conformity assessment activities in the Philippines and other WTO member countries. It is in this website that the status of ICC and PS applications could be found.

**DTI Pay** is a system for online payment facility in DTI.

**TradeNet** is an automated licensing, permit, clearance, and certification system integrated into one platform for regulatory agencies. It is a government effort, headed by the Department of Finance (DOF) and Department of Information and Communications Technology (DITC), to connect government agencies to make the trade facilitation processes become interoperable. TradeNet is established to enable traders to apply for their permits online and allow regulatory agencies to receive applications and send feedback in real-time.

**ICC Verification App** is an online mobile application that can be downloaded from App Store and Google Play for verification of ICC stickers

Winning bidder shall shoulder the cost of 1-day training (i.e. training venue; meals; training materials/kit; travel and accommodation expenses of resource persons) per group/area for 30 participants and the Secretariat. DTI shall shoulder the travel and accommodation expenses of participants. – winning bidder shall conduct one (1) day training for each user level either face to face or online depending on the situation
