Additional Requirements for Post-Qualification Process

LOT NO. 1 - Security Service for the Department of Trade and Industry (DTI) and its Attached Agencies

- 1. Comprehensive security plan for DTI, DCP and PTTC following the criteria stated in the Philippine Bidding Document.
- 2. Monthly Disposition Report (Minimum of six months: January 2019 to present) stamped and received by PNP- SOSIA.
- 3. List of deployed security personnel.
- 4. Proof that the company provided security services to at least three (3) government or private institutions for the past five (5) years with a minimum of fifty (50) deployed security personnel per company.
- 5. List of licensed firearms.
- 6. Photocopy of list of all NTC licensed communication equipment.
- 7. Certified True Copy of SSS, PhilHealth & Pag-Ibig remittances for 2020-2021.
- 8. Photocopies of pay slips of the concerned guards from the Contractor for the last three (3) months.
- 9. Proof of Red Cross training of all security guards.
- 10. The Contractor shall submit the Personal Data Sheet, copies of Private Security License Card, Police Clearance, NBI clearance, Neuro-Psychiatric Test, Drug Test, Physical Fitness certificate, Health Certificate, Gun safety seminar certificate, Training on first aid and life saving techniques certificate of the guards.

LOT NO. 2 - Close-in Security Service for the Department of Trade and Industry (DTI)

- 1. Comprehensive security plan and ensure its implementation during the entire contract duration.
- 2. Certification under oath of list of contracts completed for the last three (3) years based on the submitted statement of completed contracts.
- 3. List of deployed security personnel.
- 4. Proof that the company provided Close-in security services to at least five (5) government or private institutions for the past five (5) years.
- 5. Certified true copy of SSS, Philhealth and Pag-ibig remittances for 2020-2021 and photocopies of pay slips of the concerned close-in security personnel from the contractor the last 3 months.
- 6. Proof of Red Cross training of all close-in security guards.
