x x x For the purpose of updating the Certificate of Registration and Membership, **all Class “A” eligibility documents mentioned in this section supporting the veracity, authenticity and validity of the Certificate shall remain current and updated.** The failure by the prospective bidder to update its Certificate with the current and updated Class “A” eligibility documents shall result in the automatic suspension of the validity of its Certificate until such time that all of the expired Class “A” eligibility documents has been updated.

C. Section VII. Technical Specifications

1. No system development or enhancement, system installation, configuration, commissioning, and development/enhancement in the DTI AWS cloud account. *pd*

2. As long as the connection in accessing the DTI AWS environment is secured, the service provider is not required to provide the VPN (IPsec) communication link/line between the DTI network and the AWS cloud.
3. The Cloud Services Provider pertains to a third-party company/supplier offering a cloud-based platform.
4. Requirement of a full advantage of the AWS Cloud, hence, retain Item 6.2.
5. Hosted at Southeast Asia/Asia Pacific.
6. Most Operating System being used is Linux.
7. The existing is based on IMAGE; Change of ownership as part of the managed services cloud optimization is tagging.
8. Have current snapshot.
9. Timeline from NTP to implementation is up to 10 calendar days.
10. Deletion of the following:
 - a. The supplier must have at least two (2) ITIL Foundation Certified staff to comply with the technical requirement of this project. The said ITIL Certified Staff should be connected with the supplier for at least three (3) years and shall be the key personnel who will monitor the installation, configuration, commissioning and completeness of the proposed software development. *Must submit a photocopy of certifications and must provide a certificate of employment as a proof that they are employed with the supplier.*
 - b. The supplier must have at least one (1) Certified in Risk and Information Systems Control (CRISC) officer to comply with the technical requirement of this project. The said CRISC officer should be connected with the supplier for at least three (3) years and shall be the technology officer who will monitor the risk of the installation, configuration, commissioning and completeness of the proposed software development. *Must submit a photocopy of certification and must submit a certificate of employment as proof that he/she is employed with the supplier.*
