- 2. The bidder is not obligated to provide accommodation to performers if the performers reside in and around Metro Manila. However, for the face-to-face sessions and the culminating concert, the bidder is obligated to provide accommodation to scholars.
- 3. Accommodation that is equivalent to a three-star hotel is acceptable.
- 4. The bidder, as a Consulting Firm for the project, is allowed to maximize the approved budget for the contract. Budget allocations and expenses for the project are at the Consulting Firm's discretion.
- 5. The bidder, as a Consulting Firm for the project, is allowed to maximize the approved budget for the contract. Budget allocations and expenses for the project are at the Consulting Firm's discretion.
- 6. The DTI Team will be composed of eight (8) employees, including DTI officials, to be provided accommodation for the face-to-face sessions and the culminating concert. There should be at least three (3) solo rooms for the DTI officials who will be attending the face-to-face sessions and the culminating concert.
- 7. The bidder is permitted to conduct team teaching as long as the minimum number of instructors provided in the TOR is satisfied.
- The bidder can increase the number of instructors as the TOR provides only the minimum requirement for the project, provided, that the additional instructor is subject for approval of DTI.
- 9. The bidder can leverage existing partnerships for the benefit of the scholars as the TOR provides only the minimum requirement for the project.
