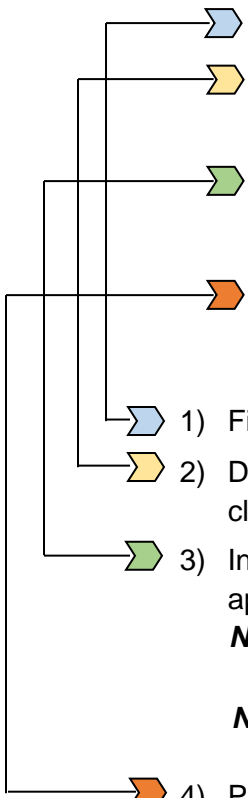

Demonstrate that all processes performed by the CB are independent of training to ensure that confidentiality, information security and impartiality are not compromised;</i></li> <li><i>c. Not give the impression that the use of both services would provide any advantage to the applicant;</i></li> <li><i>d. Not require the candidates to complete the CB's own education or training as an exclusive prerequisite when alternative education or training with an equivalent outcome exists;</i></li> <li><i>e. Ensure that personnel do not serve as examiner of a specific candidate they have trained for a period of two years from the date of the conclusion of the training: this interval may be shortened if the CB demonstrates it does not compromise impartiality.</i></li> </ul>
